The Digital Policy Office End of Programme Arrangement of the "IT Innovation Lab in Secondary Schools" Programme and the "Knowing More About IT" Programme

Purpose

The purpose of this circular memorandum is to inform all publicly-funded primary and secondary schools about the end of programme arrangement for the "IT Innovation Lab in Secondary Schools" Programme and the "Knowing More About IT" Programme of the Digital Policy Office (DPO) in the 2025/26 school year.

Background

2. The DPO launched the "IT Innovation Lab in Secondary Schools" Programme and the "Knowing More About IT" Programme in 2020 and 2021 respectively for three school years, to provide funding support for secondary and primary schools to organise IT-related extra-curricular activities, aiming to help young people build a foundation in IT, preparing them for pursuing IT-related tertiary education or careers. Both programmes have been extended through the 2025/26 school year.

Details

Exit Arrangement

3. The "IT Innovation Lab in Secondary Schools" Programme and the "Knowing More About IT" Programme are set to conclude by the end of the 2025/26 school year. Schools must submit their final funding applications by **30 September 2025** to ensure consideration before the programmes end. This deadline allows sufficient time for planning and implementing activities under the programmes. All approved activities must be completed by **31 August 2026**, the official end of the 2025/26 school year.

4. To ensure a smooth and orderly completion of the two programmes, all reports for the 2024/25 school year, including annual and financial reports, must be finalised and submitted by 31 October 2025 to facilitate the efficient processing of funding approvals, with the majority of applications expected to be granted by 31 December 2025.
